# III. Affiliated School Education and Safety (ASES) Program Report by Rosanne Curiel

Improved grades and better communication with teachers are two examples of accomplishments students' that participate in the 90 minute after-school programs that end at 6:00 p.m. Bill Young, Grace Smith, Fremont Elementary, Holtville JH, San Pasqual Elementary & Middle School, and Westmorland are in this consortium.

Other non-consortium areas that are reaping the same benefits are Blanche Charles, Jefferson, Kennedy, Mains and Rockwood in Calexico.

In February 2007 Harding, Kennedy MS, Lincoln, Meadows and Seeley received a new ASES grant.
